### Use of the Site and its contents:

In order to use the Site, the USER must be in possession of an Internet connection and adequate computing hardware whose cost is in addition to the services offered by NUTRAVALIA.

- not to use the deep linking technology, i.e. the Site's pages may not be embedded into the pages of another site, but must be accessible by opening a window;
